We are looking for enthusiastic individuals to join our Board as a new Trustee. We are a small, but high-impact charity with a friendly and dedicated team of staff, Trustees and volunteers. We are at an exciting stage of our journey having recently secured significant funding across two of our key programmes of activity and we are a confirmed finalist in the Green Category of the BBC Radio York Make a Difference Awards as well as having won "Collection Crew of the Year" at the National Awards for Excellence in Waste and Recycling.

In terms of our longer-term strategy, we are looking to update our Environment Centre located on our 24 acre nature reserve in York. Next year will see the 20<sup>th</sup> anniversary of the building's original construction and we need to both improve and adapt the space to suit our needs as well as update it in terms of the latest technology in relation to retrofitting and sustainability. On an ongoing basis we are seeking Trustees with a range of skills and lived experience, but right now we are looking for a Trustee with a background in commercial building/development/construction, conveyancing, architecture or Facilities/Property/Estate Management to assist us in this 2-3 year programme. Your role will therefore be focussed on providing oversight, advice, and expertise as we seek to make these significant changes to our building to ensure it's both fit for purpose for the charity we are today and to futureproof it for generations to come.

#### About St Nicks

St Nicks is the green heart of York: a centre for nature and green living, with an ambitious vision to enable thriving and connected biodiverse communities. The charity started as 'Friends of St Nicholas Fields' in the 1990s by transforming a former landfill site into a thriving Local Nature Reserve. Over the years, our size and ambition has grown, and we have become an established and valued part of our city community.

Our current mission is to build and connect flourishing communities through greenspace regeneration, nature-based wellbeing and sustainable living. These activities are underpinned by our values of collaboration, integrity, innovation and professionalism, and focus on three core strategic aims:

- "Nature" greenspace regeneration
- "People" improving wellbeing through nature connectedness
- "Planet" empowering communities to flourish sustainably

We have a passionate team of staff, Trustees and volunteers who run a range of projects, events and services with the help of our partners and supporter to help us achieve these aims.

We are partially funded by City of York Council and partly by grants from other sources. The rest of our income comes from membership, donations, fundraising events and other activities.

### The Board of Trustees

We have an engaged board of trustees with a broad skillset. Our trustees play an important role in shaping the direction of our charity as well as holding overall legal and financial responsibility for the whole charity, overseeing our work and ensuring we are meeting our charitable objectives. #### What do trustees do?

The Trustee role at St Nicks is a voluntary (unpaid) position. It provides an opportunity to give something back to the local community and use your skills and experience to make a meaningful difference to the environment and the lives of others.

The role of our Trustees is to:

- Hold collective overall legal and financial responsibility for St Nicks
- Ensure that we deliver on our strategic and business plans, achieve financial sustainability and manage our organisation's performance;
- Ensure that St Nicks complies with its governing document (its Articles of Association), charity law, company law and any other relevant legislation or regulations;
- Ensure that St Nicks pursues its objects as defined in its governing document;
- Ensure that St Nicks applies its resources exclusively in pursuance of its objects;
- Contribute actively to the Board of Trustees by giving firm strategic direction to St Nicks;
- Set overall policy, defining goals, setting targets, and evaluating performance against agreed targets;
- Ensure the financial stability of St Nicks.

### What would that mean for you?

Trustees are expected to attend our Management Committee meetings every two months. These are friendly and informal sessions, at which trustees review what has happened since the last meeting, hear from the Chief Executive and take any decisions that need to be taken. They are usually held in the evenings between 6-8pm, but sometimes at 8-10am depending on availability of all Trustees.

You would also need to commit approximately 2-3 hours per month to read through papers prior to meetings, read and respond to emails, and attend occasional other sub-committees, working groups or events as required.

If you are selected, we will make sure that you are properly inducted to the Board of Trustees, have a mentor while you are learning about your role and have regular reviews with our Chair.

You will be responsible to the Chair of the Board of Trustees.
